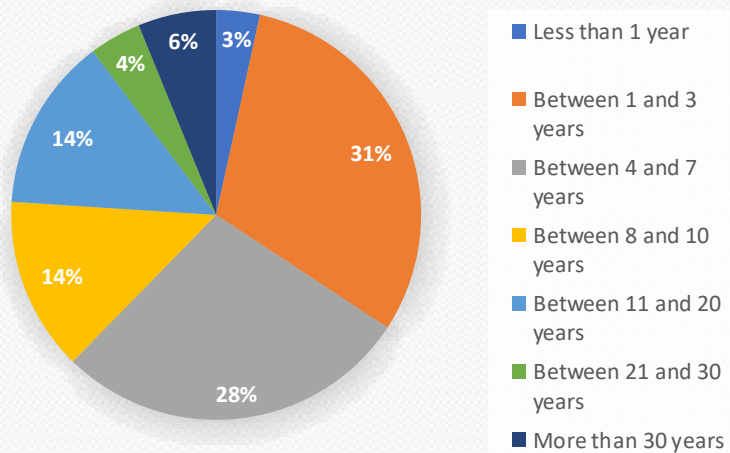

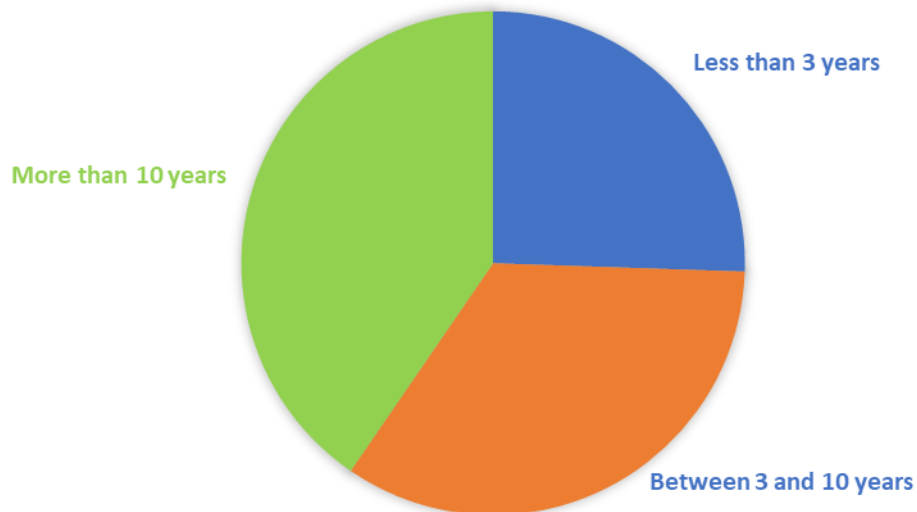

LENGTH OF SERVICE



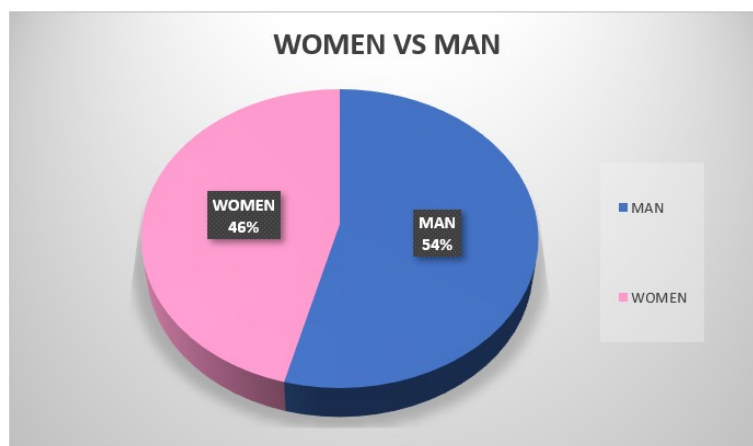
LONG-STANDING RELATIONS WITH SUPPLIERS
